MINUTES OF COUNCIL

September 22, 2016 6:40 P.M.

The Murray City Council met in regular session Thursday, September 22, 2016, at 6:40 p.m. in the Council Chambers of City Hall with Mayor Jack Rose presiding.

After a moment of silence, Jeremy Bell led the Pledge of Allegiance to the Flag.

Mayor Rose welcomed Council members and guests and called the meeting to order.

The minutes of the Council Meeting of September 8, 2016, were presented for approval. **Mr. Bell moved;** seconded by **Mr. Bohannon.** All voted aye.

Mayor Rose presented the Mayor's Report as outlined below:

- a) Scam Alerts—Mayor Rose informed members of the community regarding a consumer protection program offered by the Kentucky Attorney General's Office could be accessed through the City's website.
- b) Mayor Rose introduced Jaimey Erwin, the new Field Operations Manager for the City of Murray Natural Gas and Water Departments.

Mayor Rose said there had been no request for public comment.

Todd Solomon presented status updates on current Wastewater System projects. He said construction photos were updated weekly on the City of Murray website.

Personnel and Finance Committee Chair, Danny Hudspeth, said the Personnel and Finance Committee met prior to the Council Meeting to discuss a budget amendment for E911 equipment and a Murray Calloway County Park special allocation. He requested Council move to Agenda Item #8.

Ordinance Number 2016-1714, an ordinance amending Ordinance Number 2016-1705, which adopted the FY 2016-2017 City of Murray, Kentucky, Annual Budget by restating certain revenues and expenditures for the City of Murray Operations Budget for a Murray Calloway County Parks special allocation and E911 Emergency Fund capital equipment was presented for approval on first reading. Mr. Hudspeth moved; seconded by Mr. Billington.

Public Works Committee Chair, Butch Seargent, stated the Public Works Committee met prior to the Council Meeting to discuss a change order, gas line extension bids, and surplus property. **Mr. Seargent** said the Committee recommended Change Order #1 be paid and so **moved**; **seconded by Mr. Bohannon.** All voted aye.

Mr. Seargent said the Public Works Committee reviewed gas line extension bids and approved the low bid by T.J. Construction. **Mr. Seargent moved** for Council approval; **seconded by Mr. Bell**. Mayor Rose recognized

Jaimey Erwin, Natural Gas Field Operations Manager, who said the gas line would be extended along Highway 641 from Midway to Brandon Road. All voted aye.

Mr. Seargent said the Committee also reviewed Sanitation equipment surplus and Public Works and City vehicles surplus. Mr. Seargent recognized Luke Crawford who explained the reason for the surplus property and the legal requirements that must be met to declare City property surplus and legally sell/dispose of it. Mr. Seargent moved for Council to declare the list of Sanitation equipment (attached) surplus; Mr. Bell seconded. After discussion, all voted aye.

Mr. Seargent moved for Council to declare the list of City and Public Works vehicles (attached) surplus; **seconded by Dr. Young**. After discussion, all voted aye.

RESOLUTION OF THE CITY OF MURRAY. **KENTUCKY** Α AUTHORIZING THE MAYOR TO MAKE APPLICATION FOR AN ACCESS POINT MANAGEMENT STUDY AND, UPON APPROVAL, TO THE ENTER INTO AN AGREEMENT WITH **KENTUCKY** TRANSPORTATION CABINET, TO EXECUTE ANY AND ALL DOCUMENTS NECESSARY TO FACILITATE AND ADMINISTER THE PROJECT AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THIS PROJECT.

WHEREAS, the City of Murray Transportation Committee met on September 28, 2016, and on October 13th, 2016, to discuss current and future transportation projects and needs for the safety of its citizens and others travelling the roads of the community, and

WHEREAS, the City of Murray, Kentucky desires to make an application to the Commonwealth of Kentucky Transportation Cabinet for an access point management study along the South 12th Street corridor (US Highway 641) between Sycamore Street and Peggy Ann Drive to be administered by the Kentucky Transportation Cabinet (KYTC); and

WHEREAS, it is recognized that an application for and approval of Kentucky Transportation Cabinet funds impose certain obligations and responsibilities upon the City; and

NOW THEREFORE, BE IT HEREBY RESOLVED that the Mayor is hereby authorized to execute and furnish all required documentation, including a memorandum of agreement, as may be required by KYTC for the furtherance of the above-referenced project and to act as the authorized correspondent for said project.

A RESOLUTION OF THE CITY OF MURRAY, KENTUCKY, AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO SELL, TRANSFER AND CONVEY BY COVENANT OF SPECIAL WARRANTY, THE REAL PROPERTY SPECIFICALLY DESCRIBED HEREIN IN ACCORDANCE WITH KRS 82.083.

WHEREAS, the City of Murray, Kentucky (hereinafter referred to as "City") is the owner of the real property located on the west side of US Highway 641 (a/k/a North 12th Street), by virtue of a deed from Noal Rex Billington and wife, Daisy Dean Billington, dated August 13, 1963, of record in Deed Book 133, Page 345, in the Calloway County Court Clerk's office and more specifically described as follows:

TRACT A:

A certain tract of land as surveyed by Kyrun Jett Wood, P.L.S.#3445 and being generally located on the west side of U.S. Highway 641 (a.k.a. N. 12th Street), Murray, Calloway County, Kentucky, more particularly described as follows:

Beginning at a 1/2" diameter x 18" long rebar & cap stamped "BFW/KJW #3445" (set) 89.00 ft. at right angles from the above said highway's centerline, Station 100+49.06;

Thence with the above said highway's west right-of-way line S $22^{\circ}15'01"$ W a distance of 23.89 ft. to a 1/2" diameter x 18" long rebar & cap stamped "BFW/KJW #3445" (set);

Thence leaving the above said highway's west right-of-way line and with a new line N 69°31'10" W a distance of 225.39 ft. to a 1/2" diameter x 18" long rebar & cap stamped "BFW/KJW #3445" (set), said point being in the east property line of the Wal Mart Real Estate property (recorded in Deed Book 314, Page 316);

Thence with the above said property's east line N 01°59'05" E a distance of 132.07 ft. to a point, said point being the Bee Creek centerline;

Thence with the above said creek centerline line S 82°49'33" E a distance of 285.55 ft. to a point, said point being in the above said highway's west right-of-way line;

Thence leaving the above said creek centerline, with the above said highway's west rightof-way line and passing through a 1/2" diameter x 18" long rebar & cap stamped "REF. PT." (set) at 20.00 ft. S 23°51'34" W a total distance of 167.38 ft. to the Point of Beginning;

The above described Tract contains 0.924 acres.

BEING a part of the City of Murray property recorded in Deed Book 133, Page 345 in the Calloway County Court Clerk's office.

The above described property is subject to any right-of-ways, easements or restrictions recorded or in existence.

WHEREAS, the City is authorized pursuant to KRS 82.083(2), to sell or otherwise dispose of its real property following the procedures as established therein.

WHEREAS, the City, pursuant to KRS 820.083(3) (a) through (d), finds, concludes and determines the following:

1. The City finds that the subject real property is presumed to have been purchased for the purpose of sanitation services and it is no longer economically advantageous for the City to incur expenses to maintain the above-described real property, which does not currently generate any income for the City.

2. The City finds that it is in the public's best interest to sell the above-described real property to encourage economic growth in the area, to possibly generate revenue through ad valorem taxes and to possibly generate new employment opportunities for the area.

3. The City finds that the Mayor, or his designee, is the proper party to sign and execute any and all documents necessary, including, but not limited to, a Special Warranty Deed, to sell, transfer and convey the real property.

4. The City finds that the method of disposition to be used shall be pursuant to KRS 82.083 (4)(e) "Sold by sealed bids in accordance with the procedure for sealed bids under KRS 45A.365(3) and (4)".

LET IT BE KNOWN TO ALL PERSONS OF Murray that discrimination in the sale, rental, leasing, financing of housing or land to be used for construction of housing or in the provision of brokerage services because of race, color, religion, sex or national origin is prohibited by Title VIII of the 1968 Civil Rights Act (Federal Fair Housing Law).

It is the policy of Murray to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, religion, sex or national origin. The Fair Housing Amendments Act of 1988 expands coverage to include disabled persons and families with children. Therefore, the City does hereby pass the following Resolution.

BE IT RESOLVED that within available resources the City will assist all persons who feel they have been discriminated against because of race, color, religion, sex, national origin, disability or familial status to seek equity under Federal and state laws by filing a complaint with the U.S. Department of Housing and Urban Development, Office of Fair Housing and Equal Opportunity, Compliance Division.

BE IT FURTHER RESOLVED that the City shall publicize this Resolution and through this publicity shall encourage owners of real estate, developers and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Law and amendments and any applicable state or local laws or ordinances.

SAID PROGRAM will at a minimum include: (1) printing and publicizing of this policy and other applicable fair housing information through local media and community contacts; (2) distribution of posters, flyers, and any other means that will bring attention of those affected, the knowledge of their respective responsibilities and rights concerning equal opportunity in housing; and (3) prepare an analysis of impediments to fair housing choice and actions to mitigate such impediments.
