A MESSAGE FROM THE CHIEF OF POLICE

I am proud to present the 2023 Annual Report for the Murray Police Department. In the past year, your Police Department underwent many changes, most notably the retirement of Chief Jeffrey Liles. Chief Liles spent 12 years as our Chief of Police, and oversaw many changes in the Department. With his retirement came a new administration, although none of us are new to the Department.

2023 also saw our patrol uniform transition to the more practical "Class B" style. Other changes in the department include the transition to 12-hour patrol shifts; the addition of six new vehicles to our fleet, which will reduce wear and tear as well as maintenance costs; a complete revision of the policy and procedure manual; and movement towards a virtually paperless records system.

I am proud to announce that the Murray Police Department once again received a 100% score on our Safety & Liability review conducted by the Kentucky League of Cities. This intense review covered policy, equipment, training, and operation of the Department. Achieving a 100% score helps reduce the cost of our liability insurance.

One thing that has not changed, however, is our commitment to serving our community. Our pledge to you is that we will continue to provide professional, fair, and equitable police services to everyone who lives, works, studies, or visits the City of Murray, Kentucky.

DEPARTMENT OVERVIEW

The Murray Police Department operates at a full staff of 40 sworn police officers, six telecommunicators, and two civilian staff. The Chief of Police serves as the agency executive, and is responsible for all functions of the department. The Assistant Chief of Police is second in command and is responsible for day to day operations of the department. MPD consists of three divisions: Patrol Services, Support Services, and Community Services. Each division is under the command of a Captain and performs specific duties to help further the department's mission to provide public safety with integrity, fairness, and professionalism.

PATROL SERVICES DIVISION

The Patrol Services Division is the backbone of the Murray Police Department, and is responsible for general patrol and response in the City of Murray. Patrol Officers respond to calls for service, conduct proactive patrol to detect and deter crime, as well as engage with community members. The division consists of two patrol teams (A and B), while each team consists of two squads (Day and Night). Each squad is under the command of a Sergeant, and each Sergeant reports to the Division Commander. Patrol officers work

12-hour shifts, with rotating days off. Each team alternates working on the weekends, allowing officers to have every other weekend off. The Patrol Division operates 24 hours a day, 365 days a year to serve and protect the City of Murray.





SUPPORT SERVICES DIVISION

The Support Services Division is commanded by a Captain and is comprised by the Criminal Investigations Unit and the Telecommunications Investigations Unit. The Criminal Unit is responsible for investigating serious and complex crimes that occur in the City of Murray, as well as ongoing narcotics investigations. The CIU is under the direct command of а Sergeant. The **Telecommunications** Unit answers emergency (911) and non-emergency phone calls, provides dispatch services for Police, Fire, and EMS in the city, and maintains control of a CJIS terminal that allows access to national criminal and vehicle



The Community Services Division is commanded by a Captain and is responsible for the Department's community-oriented initiatives. This diverse division contains three School Resource Officers, records management, public information, grant management, Alcoholic Beverage Control, and community outreach. This division organizes the Citizen's Police Academy, the Novel McReynolds Youth Academy, as well as other community events. While this division is our smallest in terms of personnel, their contribution to our mission is invaluable.






