## I. PROJECT DESCRIPTION

County - Calloway

Project Description - This request is for preliminary engineering, planning, acquisition and

resident inspection for the construction of a new 5 MGD (million gallons per day), Drinking Water Treatment Plant located in the expanding

northern city limits. The project would include:

-four (4) new raw water wells with a minimum 3,500 GPM capacity -Iron removing capabilities (oxidation, clarification, and filtration)

-a 1MG clearwell

-High service pump station with 4000 GPM minimum capacity

-Backwash pumps

-Emergency standby generators with capacity to operate both the water

treatment plant and wells

- Impact of this project on firm's capacity

### IV. SCOPE OF WORK

The selected Consultant Team(s) will be required to provide Civil Design, CA, Inspection, Bid Doc preparation, pay application review, surveying as needed including the preparation of engineering studies, identification of appropriate typical sections, identifying any utility impacts, performing drainage design, developing dependable cost estimates, conducting and preparing documents for public meetings.

When Preliminary Design is complete. Final Design will include the preparations of any design studies, drainage design, final right of way plans, construction plans, traffic control plans and cost estimates as necessary to provide final Grade, Drain and Surfacing Plans for the project.

#### VI. EVALUATION FACTORS

Consultant Teams will be evaluated by the selection committee based on the following, weighted factors:

- 1. Relative experience of Consultant Team personnel assigned to project team with water treatment plant projects for local or other state governmental agencies. (15 Points)
- 2. Capacity to comply with project schedule. (15 Points)
- 3. Past record of performance on projects similar in type and complexity. (20 Points)
- 4. Project approach and proposed procedures to accomplish the goal for the project. (30 Points)
- 5. Consultant Team's offices where work is to be performed. (10 Points)
- 6. Familiarity with the KIA funded projects (10 points).

For state-funded projects, if a Selection Committee vote results in a tie between two (2) firms, one (1) of which will perform more of the work tasks in Kentucky than the other, then the former firm

shall be ranked one (1) place ahead of the latter.
